

# **SOUTH INDIAN BANK EARNS** Q1 NET PROFIT Rs 73.26 CR

South Indian Bank has announced the Q1 results with a net profit of Rs 73.26 crore as against Rs 23.04 crore during the corresponding period of the previous year. Operating profit for the first quarter has grown from Rs 269.64 crore to Rs 317.63 crore (17.80 per cent) Y-o-Y.

The operating profit of the bank improved 17.80 per cent Y-o-Y during the first quarter and net profit also registered a growth of 218.52 per cent Y-o-Y as a result of improved performance in the treasury and credit areas.

The net interest income registered a growth of 8.38 per cent Y-o-Y. Other income registered a growth of 24.68 per cent. The Gross Non Performing Assets of the bank was stable
