(39.59%) and directly (29.60%) and by Mr Dilip Modi (30.81%) (collectively the Owners) is the holding reporting company of this Company. In terms of SBO Rules, this Company i.e. DiGiSPICE Technologies Limited is only required to report details of holding reporting company.
